

20.1 Set Share Preview For Public Folder Shares

i The ability to select a file as the default preview when sharing a folder in public mode is available in FileCloud version 14.0 and later.

This will cause a persistent preview while share recipient browses the share.

To select the preview file:

- 1. Share a folder for which preview must be set.
- 2. Open the share details dialog by selecting the shared folder and clicking on 'Manage Share'.
- 3. Click on the additional settings button next to the public share permissions drop down.

Hello FileCloud Solution Partner Agreement

This Solution Partner Agreement (the "Agreement") is entered into by and between CodeLathe LLC ("CodeLathe") and ("Solution Partner") on the Effective Date.

CodeLathe may amend the terms and conditions of this Agreement at any time upon notice to Solution Partner.

License Grant .1

Subject to the terms and conditions of this Agreement, CodeLathe grants Solution Partner a non-transferable, non-exclusive, non-assignable license to market, promote, and resell software products developed by CodeLathe as listed on Exhibit A (the "Products") attached hereto, and use CodeLathe trademark, service mark, and logo solely for its performance under this Agreement. Solution Partner will place its orders for the Products directly with CodeLathe. Solution Partner shall not make any representation or warranty regarding the Products to any third party other than that authorized in writing by CodeLathe. All intellectual property rights, other than those expressly granted under this Agreement, that relate to the Products shall remain with CodeLathe.

Solution Partner may advertise in publications of general circulation that it is an authorized Solution Partner of the Products, subject to CodeLathe's prior written approval for each such publication.

Agreement is subject to approval by CodeLathe. 1.3

Prices .2

All prices for the Products provided by CodeLathe to Solution Partner are in US dollars. CodeLathe has the right to 1.1 revise the prices for the Products to Solution Partner upon ninety (90) days written notice. Such revisions shall apply to orders received by CodeLathe on or after the effective date of the revision.

Solution Partner may set the prices for the Products for resale. 2.2

Solution Partner shall be responsible for paying all taxes of any nature which become due with regard to the Products it 2.3 purchases and/or resells, except for taxes on CodeLathe's income, irrespective of which party may be responsible for reporting or collecting such taxes.

FileCloud Solution Partner pricing is listed in Exhibit A. The discounts listed in Exhibit A applies only to customer 2.4 orders, sourced by the Solution Partner.

To qualify for the pricing discounts, the solution partner needs to bring the customer on their own. If the end customer 2.5 has already registered in our trial portal the discounts don't apply.

Payment and Terms .3

Payments are due in 30 days from the invoice date and the Presentation of Product licenses 3.1

Failure of Solution Partner's clients to pay in no way releases the Partner's obligations to make full payment. 3.2

Duties of Solution Partner .4

CodeLathe Promotion: Solution Partner agrees to promote CodeLathe Products on its own website with all the 4.1 products Solution Partner carries as defined in Exhibit A. Solution Partner also agrees to add a link to FileCloud Website, www.getfilecloud.com

Technical Support: Solution Partner will support end users by providing technical support in the means of email and 4.2 phone if needed.

General: In carrying out this Agreement, Solution Partner will conduct itself in an ethical, professional and lawful 4.3 manner, will exercise its best efforts to achieve a high level of customer satisfaction, and will refrain from doing anything to impair the reputation of CodeLathe.

Limitation of CodeLathe's Obligation & Liability .5

CodeLathe shall not be liable to Solution Partner or any of its customers for any special indirect, consequential, 5.1 incidental or exemplary damages, including, but not limited to, loss of business, loss of profit, loss of or damage resulting from the loss of data, inability to access internet, or inability to transmit or receive information, caused by or resulting from, delay, non-delivery, or service interruptions caused by CodeLathe or the Products, even if CodeLathe has been advised of the possibility of such damages.

CodeLathe's liability to Solution Partner and any customer of Solution Partner is limited to the purchase price received 5.2 by CodeLathe for the relevant Products.

Solution Partner will take all necessary measures to preclude CodeLathe from being made a party to any lawsuit or 5.3 claim regarding the Products provided to customers of Solution Partner. Solution Partner hereby agrees to defend, indemnify and hold harmless CodeLathe from any and all claims of whatever nature brought by any of Solution Partner's customers against CodeLathe arising from Solution Partner's breach of this Agreement or any misstatement or wrongful omission of the Solution Partner.
